Motion carried.

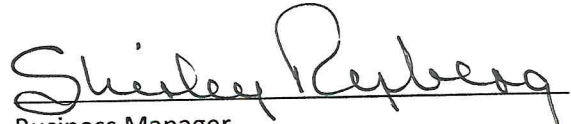

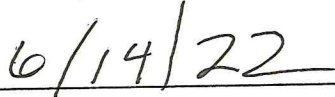
Coty Sible made a motion, seconded by Roy Kuil, to pay the bills as submitted. Motion carried.
